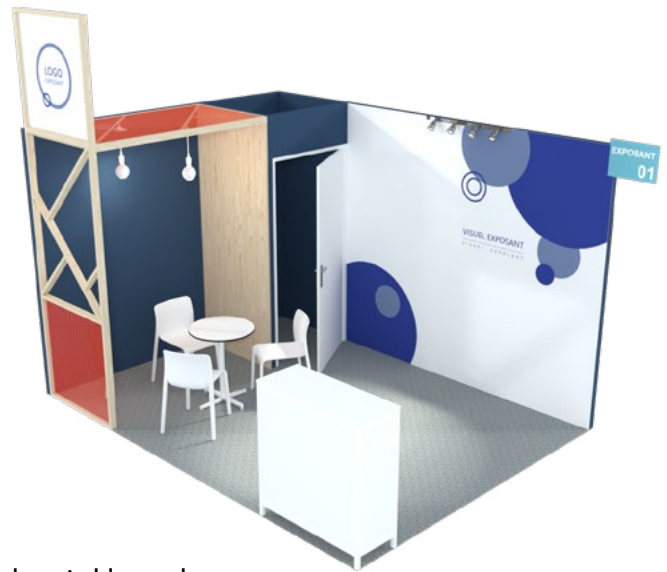
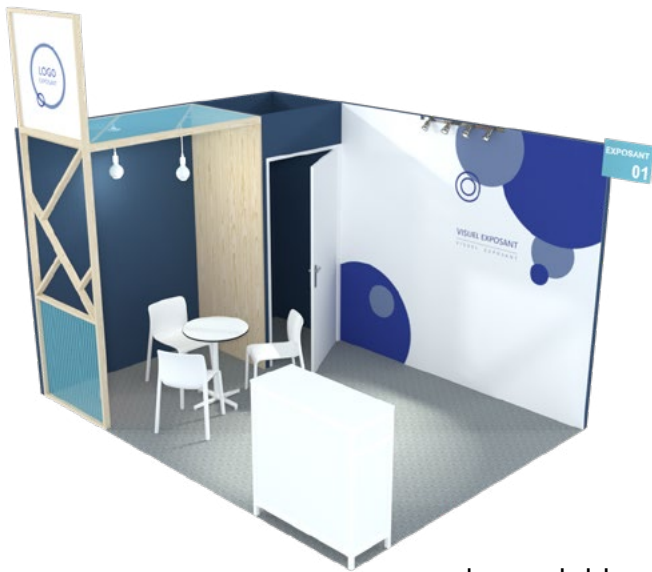

**VAPEXPO encourages all exhibitors to adopt responsible practices** to ensure satisfying quality standards as well as a complete compliance with the applicable regulatory framework of the French e-liquid market. Hence, a certain transparency will be required with regard to the e-liquids you are willing to exhibit and showcase to the public during the event you are going to participate in.

As such, you are committing to bring us the proof of it by submitting a declaration on the honor stating that you are able to provide us with the following documents, upon request from VAPEXPO:

for the e-liquids containing nicotine : the TPD (Tobacco Products Directive) registration ID number delivered by the ANSES (French Agency for Food, Environmental and Occupational Health & Safety)

for every e-liquids exhibited : the Material Safety Data Sheet or «MSDS» («FDS» in French) of the concerned e-liquid

the certifications proving that you declared your products to the INRS (French Health and Safety Research Institute) and the CAPTV (French Anti-poison and Toxin Monitoring Centres) : the registration of each e-liquid can be achieved through the following platform (English version available) : [www.declaration-synapse.fr](http://www.declaration-synapse.fr)

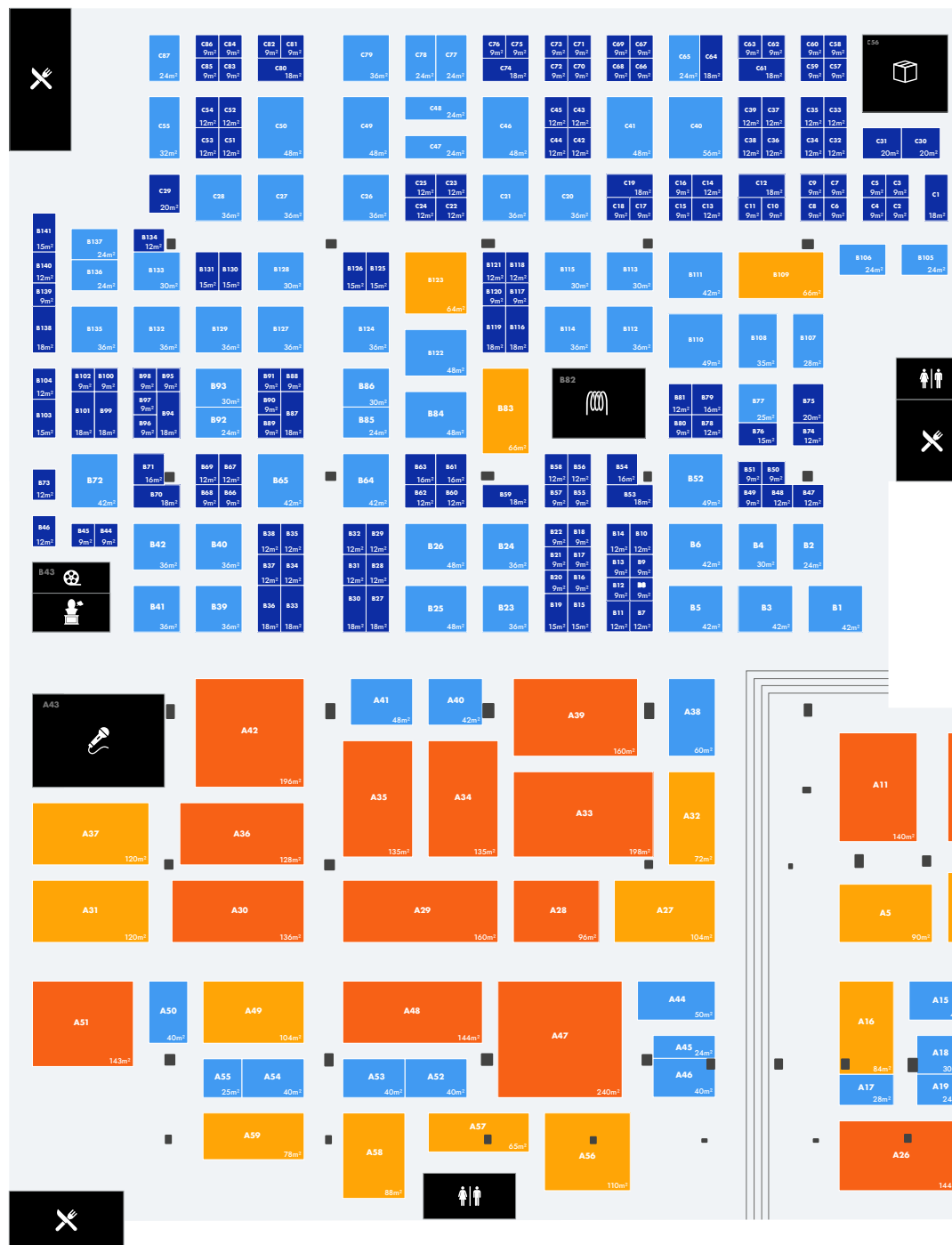
